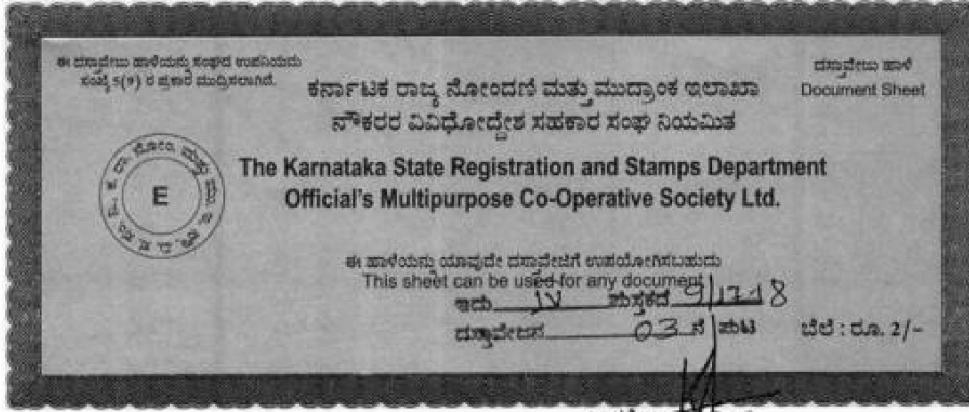

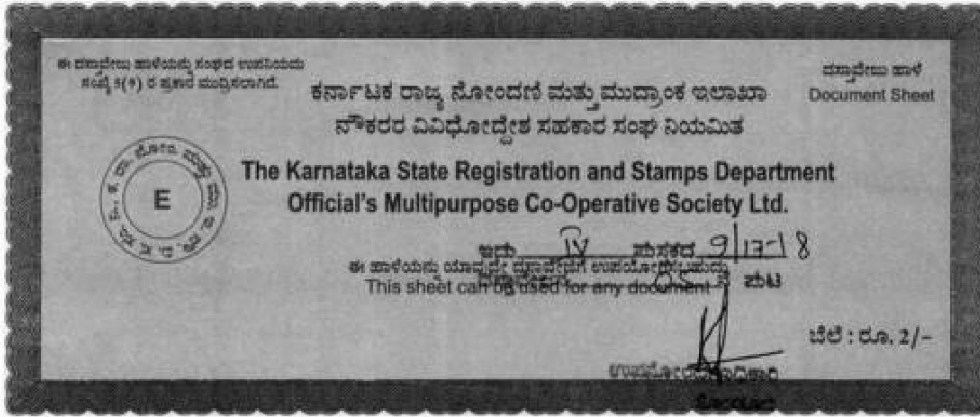

1. Name of the Trust
"BKG Foundation".

2. Office of the Trust
The office of the Trust shall be at No. 2198, BKG House, KHB Colony, Sandur-583 119, Bellary district or such other places as the Board of Trustees may decide from time to time.

3. Objects of the Trust
(a) To provide educational assistance by way of scholarships, stipend, freeship, educational loans, assistance by way of books and clothing to the deserving poor students.

(b) To run, aid and maintain schools, colleges, libraries, reading rooms, hostels, and play grounds for the benefit of general masses.

(c) To aid maintain or run hospitals, dispensaries diagnostic clinic, X-ray services for the benefit of the general and provide assistance for medical treatment to the needy persons.

(d) To aid for the better living of the needy persons by providing them food, clothing and arranging for the shelter homes for them and particularly carrying out the work of slum clearing in the city and development thereof.

(e) To assist orphan, handicapped persons and widows for earning their livelihood by arranging work for them.

(f) To assist and aid persons at the time of natural calamities like flood, famine and earthquake, etc.

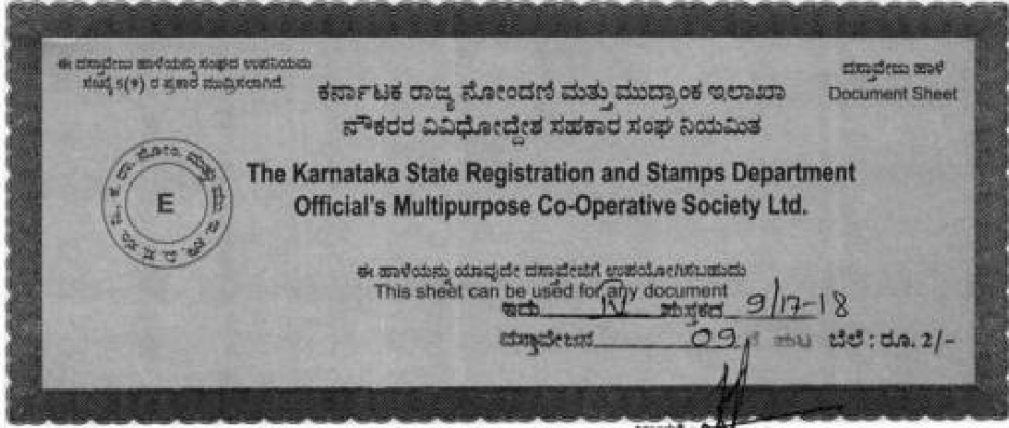

iii. The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him / her in writing by the Board of Trustees.

iv. The Trustees shall meet at least once in six months and be called within fifteen days' notice in writing indicating the place, date, hour and purpose of the meeting and shall be sent by certificate of posting or by hand. However, the notice period can be waived if all the trustees unanimously agree for a short notice.

v. The Board of Trustees who may appoint / co-opt other trustees. The trustees who are appointed in such vacancies caused by retiring trustees can continue in office for such period as decided by the Board of Trustees from time to time.

vi. The resolution passed by circulation among the trustees shall be deemed to be passed in the meeting normally constituted by the Board of Trustees.

vii. Any 2 (two) trustees shall form quorum for the meeting.

viii. The decision taken by 3/4th majority of the composition of the Board shall be final and binding on the Trust, except for decisions to dissolve or merge or sell majority of assets of the Trust, which must be taken by unanimous decision of the Board.

ix. The Board of Trustees shall elect among themselves the Chairman and Secretary who shall hold the respective position during the tenure of their trusteeship.

x. The secretary shall be the immediate head of the Trust and shall be responsible for proper management and functioning of the Trust & fulfillment of its objects, expansion of its activities, maintenance of discipline and implementation of the decision of the BOARD

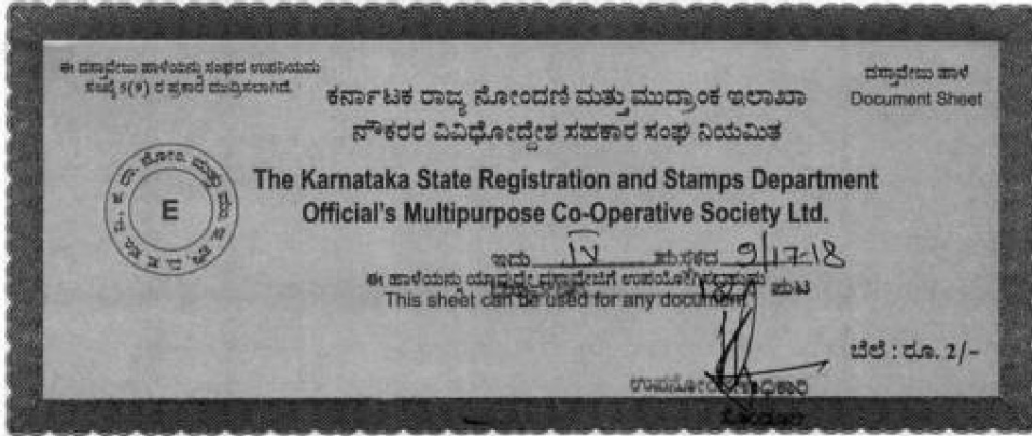

OF TRUST. Except where otherwise provided all communications intended for the TRUST should be addressed to the secretary and all correspondence notices, circular etc., should be issued under his signature. Similarly all contracts, agreements, Deed etc, should be executed under his signature.

xi. Trustee may retrieve from office by giving written notice to the other trustees and shall do so if he ceases to be a member of the congregation.

xii. Trustee may at any time or from time to time may be removed from the office by unanimous resolution of a meeting of the congregation.

xiii. Trustee whether by retirement, removal, the operation of any of the proceedings provisions shall deliver to trustee for the time being all books, records, documents, and other materials pertaining to the Trust which in his possession or under his control.

xiv. Termination of office of the Trustees: Trustee shall cease to hold office:-

- (a) If he dies.
- (b) If he resigns.
- (c) If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- (d) If he is found to have acted against the interest of the Trust.
- (e) If it is unanimously decided by the Trustees specified above that his continuation in the office is against the interest of the Trust.
- (f) Upon expiry of the period up to which the board of Trustee have nominated the trustee

xv. The Trust may borrow any monies from banks/financial institutions or any other persons against with or without the security of the assets of the Trust/ Lessor firm and such loan accounts shall be guaranteed by all the Trustess jointly and severally.

xvi. In the meeting of the Board of Trustees in the absence of the Chairman, the trustees may nominate one among them as Chairman and the matters may be decided by unanimous decision of all the trustees or by the majority and in case of equal votes in deciding the matter, the Chairman shall have power to cast the deciding votes.

6. Powers of the Board of Trustees

- i. To carry on the activities of the Trust.
- ii. To appoint the functionaries at such levels as they may deem necessary to carry out the objects of the Trust.
- iii. To delegate such powers as it may deem fit to such functionaries and fix up the responsibility and accountability.
- iv. To evaluate the functions of such functionaries and take such appropriate action as it may deem necessary, which includes terminating the employment of such functionaries if it is found that their contribution on the basis of the evaluation are not in the interest of Trust.
- v. To create or establish branches or offices at such convenient geographical places anywhere in India.

vi. "The Trust" may enter into arrangements or agreements with other trusts or bodies to act as their nominees or agents to utilise any part of their assets, for purposes mentioned in this Trust Deed and to collaborate with those organisations in India.

vii. To accept voluntary contribution in money, property or equipment or any other assistance from any member of the public or from other charitable trusts or institutions by way of donations or gifts, either to the corpus of the trust or otherwise.

viii. To acquire, purchase or otherwise use or build upon immovable properties anywhere in India for the purpose and objects of the Trust, including acquisition of lease hold rights.

ix. To maintain regularly proper books of accounts and have them duly audited by a Chartered Accountant every year. The accounts of the Trust shall be closed on 31st March every year.

x. Acquire, sell, manage invest & reinvest the Trust assets as the Trustee shall determine to be prudent under circumstances then prevailing, but without being limited in the character of investment by any statutory or other Governmental limitation on the investment of Trust Funds.

xi. The Governing Council shall function in accordance with such rules as may be framed in this behalf by the Board of Trustees from time to time.

xii. The Board of Trustees shall have powers to utilise the entire corpus or any portion of the trust funds or properties for all or any one of the above mentioned objects.

xiii. The Board of Trustees shall have absolute powers to utilise any income or benefit of the trust for the advantage and benefit of the Trust or for the advancement of the objects of the Trust.

xiv. 8. The Trustees will take their decisions in the meeting and there will be one meeting in every quarter. The proceedings for the Board Meeting will be recorded in the bound register.

13. Nature of Trust

i. It is hereby declared that the Trust created shall not be for the benefit of a particular religion, caste, creed or colour or sex, etc.

ii. The funds and the income of the Trust shall be solely utilised towards the achievement of the objects and no portion of it shall be utilised for payment to trustees by way of profit, interest, dividend, etc.

14. The Trust formed shall be irrevocable.

officers and the staff of the Trust and for other matters pertaining to the management of the Trust but the rules so framed will not be violating the clauses of the Deed itself.

16. That the purchase of agriculture land for the benefit of Trust shall be with the prior permission of the concerned authority.

17. To do all such other lawful things as may be incidental or conducive to the attainment of the objects of the Trust.
